Forty five (45) days prior to this anniversary date, you will receive a courtesy reminder to submit the firm's annual update documents through CDOT's online certification management system at <http://cdot.dbesystem.com>. However, CDOT is not responsible for undelivered notices. Failure to complete and submit your firm's annual update documents may result in decertification and removal from the Colorado UCP DBE Directory.

Changes to Your Business You must notify the Civil Rights & Business Resource Center of any changes that occur in your firm's legal structure, ownership, management, control, and/or work performed within thirty (30) days of the change. Please include any available supporting documentation in your notice.
